3. DATA PROTECTION INFORMATION for a “meniscus graft request”

- a) The legal basis for the processing of personal data provided by you in the context of this request is Art. 6 (1) lit. b GDPR. The processing of the data is mandatory as a pre-contractual measure for the processing and response to the request made here.
- b) The requested data (images, defect location) are used to measure the patient dimensions and to determine the required graft dimensions according to the method of Pollard et al. (1995) on radiographs or MRI scans (imaging), as well as to contact you (email, phone number of the requester), to clearly identify you as the person authorized to make the request (name, department, clinic or practice), and to clearly identify the request and the associated imaging (name of the patient). The transmitted data will be stored according to section c) of this data protection information for the respective period of time and will be used exclusively to determine the patient dimensions and for matching with the meniscus grafts by DIZG staff.
- c) The transferred data (forms and image files) are electronically recorded and stored for the purpose of meniscus matching.
- aa. Should an appropriate meniscus graft be identified and subsequently ordered by the requester, the respective data will be retained and stored for 30 years after shipment of the graft in accordance with Section 199 II of the German Civil Code. Unless we have a continuing legitimate interest in further storage.
- bb. Should an appropriate meniscus graft be identified but not ordered within 6 months, the respective data will be deleted no later than 6 months after the receipt of the request. The period of storage of the request data of up to 6 months is justified by the need for confirmation of funding of the transplants by the service providers (health insurance companies).
- cc. If an appropriate meniscus graft is not available, the respective data will be deleted within 2 weeks after receipt of the request. If you wish to have the menisci of new batches of meniscus transplants checked for fit with the existing request, please tick the box below. In this case, the DIZG will store the existing request as well as all associated data (imaging, measured values) for a total of two years from receipt of the request. If an appropriate meniscus graft is available within these 2 years, the regulations of 3. aa. and 3. bb. apply. If no suitable meniscus transplant has been identified by the end of these two years, the request expires and the data is deleted. If there is still a need for a meniscus graft, a new request must be submitted. In this case, please contact graftmatching@dizg.de.
- d) The DIZG will provide the requester or patient (hereinafter: data subject) with information on the stored personal data relating to the data subject free of charge upon request and according to legal conditions. The data subject also has the right, according to legal conditions, to demand the correction, deletion, restriction of processing or transfer of his or her data to a third party and to object to data processing according to Section 21 (1) GDPR. If an appropriate meniscus graft is not available at the time of the request, the present request should be matched with newly released menisci batches for the two-year period.
